

## PRIVACY POLICY FOR WEBSITES

### 1) Information about the collection of personal data

(a) Information about the collection of personal data when using our website. Personal data is any data personally available to you, e.g. Name, address, e-mail addresses, user behavior.

(c) When contacting us by e-mail or through a contact form, the information provided by you (e-mail address, name, telephone number, company, etc.) will be stored by us solely to process your request. We delete the data that arises in this context after the storage is no longer required, or limit the processing if there are statutory retention requirements.

(d) If we rely on commissioned service providers for individual functions of our offer or if you wish to use your data for advertising purposes, you will be informed in detail below about the respective events. In doing so, we also name the specified criteria for the storage duration.

### 2) Your Rights

(a) You have the following rights regarding your personal data:

- right to information,
- right to rectification or deletion,
- right to restriction of processing,
- right to object to the processing,
- Right to data portability.

### 3) Collection of personal data when visiting our website

- a) In the case of merely informative use of the website, ie if you do not register or otherwise provide us with information, we will only collect the personal data that your browser transmits to our server. If you wish to view our website, we collect the following information that is technically necessary for us to display our website and to ensure its stability and safety. (The legal basis is Article 6 (1) (1) (f) GDPR):
- IP address
  - Date and time of the request
  - Time zone difference to Greenwich Mean Time (GMT)
  - content of the request (concrete page)
  - Access Status / HTTP status code
  - each transferred amount of data
  - Website from which the request comes
  - browser
  - Operating system and its interface
  - Language and version of the browser software
- b) In addition to the aforementioned data, cookies are stored on your computer when you use our website. Cookies are small text files that are stored on your hard drive assigned to the browser you are using and by which the body that sets the cookie (here through us) receives certain information. Cookies can not run programs or transmit viruses to your computer. They serve to make the Internet offer more user-friendly and effective overall.
- c) Use of cookies
- I) This website uses the following types of cookies, the scope and operation of which are explained below:
- Transiente Cookies (b)
  - Persistente Cookies (c)
- II) Transient cookies are automatically deleted when you close the browser. These include in particular the session cookies. These store a so-called session ID, with which various requests from your browser can be assigned to the common session. This will allow your computer to be recognized when you return to our website. The session cookies are deleted when you log out or close the browser.
- III) Persistent cookies are automatically deleted after a specified period, which may differ depending on the cookie. You can delete the cookies in the security settings of your browser at any time.
- IV) You can configure your browser setting according to your wishes and, for example, refuse to accept third-party cookies or all cookies. Please be aware that you may not be able to use all features of this site.
- d) Analysis tools and advertising
- Google Analytics: This website uses functions of the web analytics service Google Analytics. Provider is Google Inc., 1600 Amphitheater Parkway, Mountain View, CA 94043, USA. Google Analytics uses so-called "cookies". These are text files that are stored on your computer and that allow an analysis of the use of the website by you. The information generated by the cookie about your use of this website is usually transmitted to a Google server in the USA and stored there. Google Analytics cookies are stored on the basis of Art. 6 para. 1 lit. f DSGVO. The website operator has a legitimate interest in analyzing user behavior in order to optimize both its website and its advertising.
  - IP anonymization: We have activated the function IP anonymization on this website. As a result, your IP address will be truncated by Google within member states of the European Union or other parties to the Agreement on the European Economic Area prior to transmission to the United States. Only in exceptional cases will the full IP address be sent to a Google server in the US and shortened there. On behalf of the operator of this website, Google will use this information to

evaluate your use of the website, to compile reports on website activity and to provide other services related to website activity and internet usage to the website operator. The IP address provided by Google Analytics as part of Google Analytics will not be merged with other Google data.

- Browser Plugin: You can prevent the storage of cookies by setting your browser software accordingly; however, please note that if you do this, you may not be able to use all the features of this website to the fullest extent possible. In addition, you may prevent the collection by Google of the data generated by the cookie and related to your use of the website (including your IP address) as well as the processing of this data by Google by downloading the browser plug-in available under the following link and install: <https://tools.google.com/dlpage/gaoptout?hl=en>.

- Order data processing: We have signed an agreement with Google for contract data processing and fully implement the strict requirements of the German data protection authorities when using Google Analytics.

- Demographics in Google Analytics: This website uses the demographics feature of Google Analytics. As a result, reports can be produced that contain statements on the age, gender and interests of the site visitors. This data comes from interest-based advertising from Google and third-party visitor data. This data can not be assigned to a specific person. You can disable this feature at any time through the ad settings in your Google Account, or generally prohibit the collection of your data by Google Analytics as outlined in the section "Opposition to Data Collection".
